



Notice of Availability of Separate Payments for Contraceptive Products

Your employer has certified that your group health plan qualifies for an accommodation with respect to the federal requirement to cover all Food and Drug Administration-approved contraceptive products for women, as prescribed by a health care provider, without cost sharing. This means that your employer will not contract, arrange, pay, or refer for contraceptive products coverage. Instead, MedImpact will provide separate payments for your eligible contraceptive drugs and devices that aren't covered by your group health plan, for as long as you are enrolled in your group health plan. Your employer will not administer or fund these payments. If you have any questions about this notice, contact the Customer Service Help Desk at 1-800-361-4542.

MedImpact will provide separate payment for contraceptive products that are generic or branded products where generics are not yet available at no cost to you when prescribed by your health care provider and filled at a network pharmacy. **A separate ID card is not required to access this benefit.** Examples of covered products are listed below:
